## Application for a BASIC KEEP RESCUED ANIMALS PERMIT (Class 1A)

Issued pursuant to Section 58, National Parks and Wildlife Act, 1972

A Basic Keep Rescued Animals permit is required when the applicant intends to care for rescued animals only and has more than one 'basic' rescued animal.

Please note this permit does not take the place of a Protected Animals Rescue Permit. A Protected Animals rescue permits is still required for each individual rescued animal.

This permit is issued to an individual and not to rescue groups or organisations. The applicant must reside in South Australia. There is no fee associated with this application.

## Please read the following carefully.

Before completing this application, the applicant should read the information 'Rescuing Protected Animals in South Australia' (available from the website or from the Fauna Permit Unit).

Any intentional misleading or false declarations made on this application may result in legal action being taken against the applicant.

## Conditions of the Keep Rescued Animals Permit

If the animals under the Keep Rescued Animals permit breed, the permit holder will be required to obtain a Specialist permit and pay the required fee.

If a holder of a Keep Rescued Animals Permit keeps and/or sells any other non-rescued protected animal (eg non-rescued animals from the basic species list) s/he will require a Keep and Sell permit and pay a fee.

The holder of this permit is prohibited to sell protected animals.

The holder of this permit it prohibited to export, transfer, give away or otherwise dispose of the animal(s) without written authority from the Director of National Parks and Wildlife.

The holder of this permit is required under the *National Parks and Wildlife Act 1972* to record information in a record book on all animals kept under this permit.

The holder of this permit is required under the *National Parks and Wildlife Act 1972* to submit an annual stock due within 14 days of the 30 June each year.

I agree to follow all conditions outlined with this permit. I declare that the information enclosed within is true and that the statement about protected animals in my possession or under my control as listed is complete and accurate

WARNING: ON EXPIRATION OF YOUR PERMIT, THE ONUS IS ON YOU TO RENEW. While the Fauna Permit Unit issues renewal notices, it will not be responsible for the non-receipt of such a notice.
